FLEXIBILITY AND CONTROL

Using Stewart Title's straightforward documentation tools, lawyers and their staff can easily complete their policy requirements at their own pace via STEPS. Lawyers still need to conduct the standard title search and indicate if there are any unusual matters that affect title.

EC members do not underwrite the transaction, Stewart Title Guaranty Company does. Stewart Title waives its rights of subrogation against lawyers in all cases except in those that include willful misconduct or gross negligence.

The EC Program compensates lawyers for their efforts in certifying title and **this legal fee can be passed onto the client or retained by counsel**. While the legal fee should be disclosed to clients, it is up to the lawyer to choose how best to serve them.

EC members are not obligated to use Stewart Title exclusively and compliance with relevant Law Society rules is encouraged.

The Program is available for residential properties of up to six units. Commercial policy orders are also available through other programs at Stewart Title.

STEPS
